

# **Terms of Service**

These Terms of Service (**Terms**) set out the terms and conditions under which The Kids Research Institute Australia ABN: 86 009 278 755 (trading as CliniKids) (**CliniKids**) grants You access to the training courses and materials provided by CliniKids and the terms on which training via face-face, online or blended options will be provided (**Courses**). By registering and accepting these Terms, you are agreeing to be bound by these Terms and represent that you are over 18 years of age.

# **Registration and Course Selection**

Before registering for the Courses, you agree that You:

- a) have read and understood the Course description in detail; and
- b) have understood the different components, training dates, video assignments and deadlines for the Course and can commit to each.

Certain Courses require specialised training and qualifications in order to be eligible for registration. By registering, You confirm that you hold all qualifications and/or experience listed as 'required' for each Course. CliniKids reserves the rights to request further information on qualifications or experience from You and to determine eligibility for access to Courses in our sole discretion.

Where You are registering for any Course through an organisation or business, You acknowledge that access to the Course is granted to individuals and certificates and accreditations are issued in the name of the individuals in their personal capacity.

#### **Trainer Led Online and Face-Face Course requirements**

- Participants understand that it is their responsibility to find 1-2 suitable volunteers for video submissions prior to the start of the Course. For some face-to-face training, a volunteer subject may be sourced for the group. This is confirmed in the description of each Course. You are responsible for securing any necessary consents to use this material in accordance with industry standards on obtaining informed consent.
- It is expected that You will be an active participant in the Course and the group discussions, and we will provide reasonable accommodations to ensure full participation when given advance notice. If you are absent and miss key components of the Course, or do not adequately participate in the discussions and tasks for the Course, you will not be able to complete the Course requirements and will not receive a Course completion certificate. This will be determined by the trainer and is subject to CliniKids sole discretion. Depending on the circumstances around the absence, it may be possible to complete the Course during the next available dates, subject to CliniKids discretion and availability.

### **Payments**

- Until payment of the Course fee (**Fee**) has been received your Course registration is not secured. You can pay via credit card at time of registration.
- If you wish to request an invoice prior to payment of the Fee, please email <u>us</u>, however Course registration is not secured and access to materials will not be released prior to payment.

#### **Cancellation & Refunds**

Clinikids reserves the right to change dates or cancel Courses due to unforeseen events. In the event of such cancellation, we will work with you to reschedule to another date or time or provide a refund.



# For trainer led online and face to face Courses

- Registered participants who are unable to attend must notify CliniKids
- If you wish to cancel your registration prior to the commencement of the Course, if cancellation request is received:
  - prior to 15 business days before Course commencement, the Fee will be refunded, minus a \$95, which
    be deducted from the refund as an administration fee plus a fee for any digital resources or e-learning
    modules provided as part of the Course for which you have been granted access.
  - o Within 14 business days before Course commencement, no refunds will be given.
- If You cancel your registration and you have already received print materials, these resources must be returned to CliniKids at your cost. Refunds will not be finalised until resources have arrived at CliniKids in a satisfactory condition. If not returned, the reasonable cost of the resources will be deducted from the refund amount.
- If you wish to request a transfer of your registration to another eligible person, please contact <u>Us</u> with details of the other eligible participant at least 15 business days prior to the commencement date of the Course. All transfers are subject to agreement by CliniKids in our sole discretion.
- If you miss part of the Course due to an absence, you will not be eligible for a refund.

### For self-paced e-Learning courses

- No refunds will be given where the Course has been commenced. CliniKids will offer refunds for Courses which
  have not been started and/or where access to materials has not been granted, where you have contacted <u>Us</u>
  within 48 hours after registration and payment of the Fee \$95 will be deducted from any refund as an
  administration fee.
- Other than as set out above, CliniKids does not generally give refunds if you have changed your mind. CliniKids will offer refunds where You are entitled to a refund under Australian Consumer Law.

### **Course rules**

CliniKids wants this to be a positive experience for all participants, so we have some Course rules:

- Disrespectful or disruptive behaviour to the trainers, other participants or volunteers will not be tolerated;
- No video recording of the trainers, participants or volunteers will be permitted;

Failure to comply with these rules will lead to removal of access to the Course and no refund will be given.

### **Access to Online Materials**

- In order to access the online materials for the Course (**Online Materials**) You will be required to create an account with our third-party provider (**Course Platform**), and as part of this process you will need to have provided us with your full name and a valid email address and/or a valid address and have fully paid for the Course.
- You will be granted access to the Course Platform from the date of payment of the Fee and You will continue to have access to the Course Platform and all available resources for a period of 3 months for trainer led courses and 1 month for self-paced e-Learning courses (starting from the last Course date).
- It is Your responsibility to download any required resources prior to the end of Your access period.
